1. ALL ACCOUNTS MUST BE PAID ON OR BEFORE THE 10TH DAY OF THE MONTH.
2. **WHEN AN ACCOUNT IS NOT PAID FOR A PERIOD OF TWO MONTHS, A REGISTERED LETTER WILL BE SENT TO THE ABOVE ADDRESS OF THE MEMBER CONCERNED. IF THE ACCOUNT IS NOT PAID IN FULL, WITHIN A FURTHER PERIOD OF 30 DAYS FROM THE DATE ON WHICH THE LETTER WAS SENT, THE HORSE(S) BELONGING TO THE MEMBER CONCERNED WILL BECOME THE PROPERTY OF THE CLUB, AND THE HORSE(S) WILL BE SOLD TO RECOVER COSTS IN WHOLE OR IN PART.**
